Transfer Station News & Notes

\$3.00/Ton Recycling Enhancement Act Tax - In notices that were sent with previous months' statements, the MCMUA informed its customers of its plans to increase the tipping fee by \$3.00/ton to account for the \$3.00/ton recycling tax that was imposed by the state beginning April 1, 2008. Please be aware that this tax will be charged on every ton of waste delivered to the transfer stations for disposal, and the MCMUA will submit payments to the state for this tax on a guarterly basis in accordance with this new Recycling Enhancement Act (P.L. 2008, C6). As a hauler using the MCMUA transfer stations, you will have no requirement to submit any recycling tax directly to the state. The tax will be included in the tipping fee, which has been increased by \$3.00/ton to account for the tax. Please be aware you may or may not be responsible for submission of the recycling tax for other hauling/disposal activities you participate in outside of Morris County. Finally, the law allows for the pass-through of this tax obligation to your customers in amounts equivalent to the tax.
