Transfer Station News & Notes

Tipping Fees to Increase as of January 1, 2023 - Please be advised that starting on January 1, 2023 the tipping fees charged for the disposal of solid waste types at the MCMUA transfer stations will be increased by 4.88% or \$5.00/ton. The 2022 tipping fee of \$102.50/ton for the disposal of all waste types will be increased to \$107.50/ton. Please see the tipping fee chart below for details:

MCMUA TRANSFER STATIONS - INFORMATIONAL UPDATE

TYPE 13C IS STILL CONSIDERED TRASH/MORRIS COUNTY WASTE FLOW

On July 13, 2021, New Jersey Department of Environmental Protection (NJDEP) certified as approved the Morris County's Solid Waste Management Plan (Plan) directing all Morris County solid waste generated within Morris County to the Morris County Municipal Utilities Authority (MCMUA) transfer stations for disposal. The MCMUA transfer stations are located in Mount Olive and Parsippany-Troy Hills Townships. This means if generated within Morris County, all waste Types 10 (Municipal Solid Waste), 13 (Bulky), **13C (Construction and Demolition)**, 23 (Vegetative), 25 (Animal Processing), and 27 (Non-Hazardous Dry Industrial) are required to be delivered to the MCMUA transfer stations.

Please understand that Morris County and the Morris County Solid Waste Management Plan, as approved by NJDEP, places a strong emphasis on source separation recycling as the primary means to extract recyclables from solid waste disposables. Additionally, regulatory flow control is not asserted on source-separated recyclables and therefore, if Morris County waste generators separate recyclables from disposable at the point of generation, the source-separated recyclables may be delivered to a recycling facility equipped and approved to recycle these source separated materials. It should be further noted that if the material recycling facility or MRF has the capabilities; the source separate recyclables can be commingled with each other for delivery to such a recycling facility. For instance, recyclable sheetrock, wood and metal, etc. may be commingled together after being separated from disposables at a job site. In this scenario, only the disposable portion of this waste stream generated at the site is required to be delivered for disposal to the MCMUA transfer stations.
